United States Commercial Slaughter

Commercial red meat production for the United States totaled 4.91 billion pounds in March 2023, down 1 percent from the 4.98 billion pounds produced in March 2022.

Beef production, at 2.40 billion pounds, was 4 percent below the previous year. Cattle slaughter totaled 2.94 million head, down 3 percent from March 2022.

Veal production totaled 4.20 million pounds, 15 percent below March a year ago. Calf slaughter totaled 26,200 head, down 20 percent from March 2022.

Pork production totaled 2.49 billion pounds, up 1 percent from the previous year. Hog slaughter totaled 11.5 million head, up 2 percent from March 2022.

Lamb and mutton production, at 12.7 million pounds, was up 3 percent from March 2022. Sheep slaughter totaled 198,800 head, 6 percent above last year.

Pacific Region Commercial Slaughter

California's production of red meat during March 2023 totaled 123 million pounds (dressed weight), 23 percent below than March 2022. This figure includes slaughter in Federally-inspected and state-inspected plants, but excludes farm slaughter. In March 2023, the average live weight of cattle slaughtered in California was 1,330 pounds, sheep and lambs averaged 161 pounds, and hogs averaged 232 pounds. In Hawaii, 800,000 pounds of red meat were produced in March 2023, and 100,000 pounds of red meat were produced in Nevada.
