

CASH RECEIPTS

Cash receipts from marketings of all farm commodities in Illinois during 1999 totaled 6.8 billion dollars, 16 percent less than during 1998. Receipts from crops totaled 5.2 billion dollars, down 19 percent from 1998, and represented 77.4 percent of the total cash receipts. Livestock receipts totaled 1.5 billion dollars, down three percent from 1998, and accounted for 22.6 percent of the total.

Cash receipts for corn totaled 2.6 billion dollars, 37.7 percent of the total, and were down 16 percent from 1998. Soybean receipts, at 2.1 billion dollars, decreased 24 percent from 1998, and accounted for 31.2 percent of total cash receipts. Wheat cash receipts in 1999 decreased to 120 million dollars, 25 percent less than 1998.

During 1999, cash receipts decreased five percent for hogs but increased three percent for cattle. Total receipts for hogs were 647 million dollars, 9.5 percent of the total cash receipts. Receipts for cattle went up to 487 million dollars and accounted for 7.2 percent of the total. Receipts for dairy products decreased seven percent to 296 million dollars.
