KANSAS CROP PROGRESS AND CONDITION

MANHATTAN, Kan. November 13, 2023 - For the week ending November 12, 2023, there were 6.7 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 29% very short, 40% short, 30% adequate, and 1% surplus. Subsoil moisture supplies rated 33% very short, 40% short, 26% adequate, and 1% surplus.

Field Crops Report: Winter wheat condition rated 15% very poor, 18% poor, 36% fair, 28% good, and 3% excellent. Winter wheat emerged was 86%, ahead of 74% last year and 81% for the five-year average.

Corn harvested was 97%, near 96% last year and 93% average.

Soybeans harvested was 92%, equal to last year, and ahead of 86% average.

Sorghum harvested was 90%, near 89% last year, and ahead of 82% average.

Cotton condition rated 3% very poor, 15% poor, 43% fair, 36% good, and 3% excellent. Cotton harvested was 65%, behind 77% last year, but well ahead of 38% average.

Sunflowers harvested was 87%, equal to last year, and ahead of 82% average.

Pasture and Range Report: Pasture and range conditions rated 24% very poor, 32% poor, 33% fair, 10% good, and 1% excellent.
