KANSAS CROP PROGRESS AND CONDITION

MANHATTAN, Kan. August 18, 2025 - For the week ending August 17, 2025, there were 6.2 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 7% very short, 23% short, 64% adequate, and 6% surplus. Subsoil moisture supplies rated 9% very short, 25% short, 60% adequate, and 6% surplus.

Field Crops Report: Corn condition rated 3% very poor, 10% poor, 27% fair, 44% good, and 16% excellent. Corn silking was 95%, near 99% last year and 97% for the five-year average. Dough was 78%, behind 87% last year, and equal to average. Dented was 37%, behind 46% last year, and near 38% average. Mature was 1%, behind 6% last year, and near 5% average.

Soybean condition rated 1% very poor, 5% poor, 26% fair, 55% good, and 13% excellent. Soybeans blooming was 87%, near 89% both last year and average. Setting pods was 69%, near 65% last year and 67% average.

Sorghum condition rated 4% very poor, 7% poor, 29% fair, 44% good, and 16% excellent. Sorghum headed was 72%, behind 79% last year, and near 73% average. Coloring was 19%, behind 27% last year, and equal to average. Mature was 1%, equal to last year.

Cotton condition rated 0% very poor, 10% poor, 37% fair, 35% good, and 18% excellent. Cotton setting bolls was 91%, near 92% last year, but ahead of 82% average. Bolls opening was 9%, near 11% last year, and equal to average.

Pasture and Range Report: Pasture and range conditions rated 4% very poor, 9% poor, 28% fair, 51% good, and 8% excellent.
