KANSAS CROP PROGRESS AND CONDITION

MANHATTAN, Kan. September 15, 2025 - For the week ending September 14, 2025, there were 5.0 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 3% very short, 15% short, 69% adequate, and 13% surplus. Subsoil moisture supplies rated 6% very short, 20% short, 65% adequate, and 9% surplus.

Field Crops Report: Winter wheat planted was 4%, near 8% last year and 7% for the five-year average.

Corn condition rated 4% very poor, 9% poor, 24% fair, 45% good, and 18% excellent. Corn dented was 94%, near 93% last year and 91% average. Mature was 55%, behind 70% last year, and near 59% average. Harvested was 10%, behind 24% last year and 19% average.

Soybean condition rated 1% very poor, 5% poor, 24% fair, 55% good, and 15% excellent. Soybeans setting pods was 96%, equal to last year, and near 95% average. Dropping leaves was 24%, behind 35% both last year and average.

Sorghum condition rated 4% very poor, 6% poor, 24% fair, 45% good, and 21% excellent. Sorghum coloring was 76%, near 78% last year and 77% average. Mature was 29%, near 33% last year, but ahead of 24% average. Harvested was 3%, near 5% last year, and equal to average.

Cotton condition rated 0% very poor, 7% poor, 29% fair, 43% good, and 21% excellent. Cotton bolls opening was 20%, well behind 52% last year and 47% average.

Pasture and Range Report: Pasture and range conditions rated 4% very poor, 9% poor, 27% fair, 50% good, and 10% excellent.
