## KANSAS CROP PROGRESS AND CONDITION

**MANHATTAN, Kan. September 22, 2025** - For the week ending September 21, 2025, there were 4.3 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 3% very short, 14% short, 68% adequate, and 15% surplus. Subsoil moisture supplies rated 6% very short, 19% short, 65% adequate, and 10% surplus.

**Field Crops Report:** Winter wheat planted was 9%, behind 15% last year and 16% for the five-year average. Emerged was 1%, near 2% both last year and average.

Corn condition rated 4% very poor, 8% poor, 27% fair, 45% good, and 16% excellent. Corn dented was 97%, equal to last year, and near 96% average. Mature was 70%, behind 83% last year, and near 74% average. Harvested was 20%, behind 39% last year and 29% average.

Soybean condition rated 2% very poor, 6% poor, 24% fair, 56% good, and 12% excellent. Soybeans dropping leaves was 41%, behind 52% last year and 50% average. Harvested was 1%, near 4% both last year and average.

Sorghum condition rated 4% very poor, 7% poor, 26% fair, 45% good, and 18% excellent. Sorghum coloring was 86%, near 89% last year and 87% average. Mature was 38%, behind 47% last year, and equal to average. Harvested was 4%, behind 10% last year, and near 6% average.

Cotton condition rated 0% very poor, 11% poor, 31% fair, 42% good, and 16% excellent. Cotton bolls opening was 22%, well behind 64% last year and 60% average.

**Pasture and Range Report:** Pasture and range conditions rated 4% very poor, 10% poor, 27% fair, 51% good, and 8% excellent.
