KANSAS CROP PROGRESS AND CONDITION

MANHATTAN, Kan. November 18, 2025 - For the week ending November 16, 2025, there were 6.9 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 6% very short, 24% short, 67% adequate, and 3% surplus. Subsoil moisture supplies rated 7% very short, 21% short, 70% adequate, and 2% surplus.

Field Crops Report: Winter wheat condition rated 4% very poor, 6% poor, 34% fair, 48% good, and 8% excellent. Winter wheat planted was 95%, near 99% last year and 98% for the five-year average. Emerged was 85%, behind 90% last year, and near 86% average.

Corn harvested was 92%, behind 99% last year and 97% average.

Soybeans harvested was 91%, behind 98% last year, and near 94% average.

Sorghum harvested was 77%, behind 92% last year and 91% average.

Cotton harvested was 30%, well behind 66% last year and 59% average.

Sunflowers harvested was 74%, behind 92% last year and 90% average.

Pasture and Range Report: Pasture and range conditions rated 5% very poor, 9% poor, 31% fair, 49% good, and 6% excellent.
