KANSAS 2025 PROSPECTIVE PLANTINGS

MANHATTAN, Kan. March 31, 2025 - Kansas **corn** growers intend to plant 6.40 million acres this year, up 2% from 2024, according to the USDA's National Agricultural Statistics Service.

Soybean planted acreage is expected to be 4.30 million acres, down 5% from last year.

Winter wheat acres seeded in the fall of 2024 are estimated at 7.30 million, down 4% from last year.

Sorghum growers in Kansas intend to plant 3.10 million acres, up 3% from a year ago.

All hay acreage to be harvested is expected to total 2.05 million acres, down 4% from last year's acreage.

Sunflower producers expect to plant 15,000 acres, up 43% from 2024. **Oil** varieties account for 13,000 acres, up 37% from a year ago. **Non-oil** varieties made up the balance of 2,000 acres, up 100%.

Oat intentions are estimated at 95,000 acres, down 41% from last year.

Canola planted acreage is expected to be 10,000 acres, up 18% from 2024.

Barley area planted is expected to be 10,000 acres, unchanged from last year.

Cotton producers expect to plant 140,000 acres, up 7% from a year ago.

Estimates in this report are based on a survey conducted during the first two weeks of March.
