Homegrown forages are charged at their market price to reflect the opportunity cost of using the forages in cow-calf production. <sup>5/</sup>Percent of total pasture cost from charge on owned pasture. Owned pasture is charged a pasture rental rate to reflect the opportunity cost of using the pasture in cow-calf production.
