AGRICULTURAL EXPORTS

Agricultural exports from Kentucky during Fiscal Year 2007 were valued at \$1.21 billion. This was up 11 percent from the revised FY 2006 value of \$1.10 billion. Unmanufactured tobacco at \$386.3 million remained the number one commodity, live animals and meat (including horses, excluding poultry) was second with \$321.1 million. Feed grains and products were up with \$147.5 million in value. Soybeans and products decreased in value at \$119.8 million. Poultry and products increased in value at \$94.0 million. Wheat and products were sixth and decreased in export value with \$69.8 million.

Value of U.S. agricultural exports totaled \$81.9 billion in FY 2007, up \$13.4 billion from FY 2006. Feed grains and products were the highest valued commodity with \$11.8 billion, followed by soybeans and products with \$11.0 billion. Exports of wheat and products were valued at \$8.46 billion. California continued to lead State agricultural exports with \$11.3 billion. Iowa was second with \$5.25 billion, ahead of Texas with \$5.20 billion. Rounding out the top 10 States were Nebraska, Kansas, Illinois. Minnesota, Washington, North Dakota, and Indiana. Kentucky ranked 21st in all exports. The FY 2008 forecast for U.S. agricultural exports at \$108.5 billion, was up \$26.6 billion from FY 2007.
