Week Ending: August 4, 2019

According to the National Agricultural Statistics Service in Mississippi, there were 4.8 days suitable for fieldwork for the week ending Sunday, August 4, 2019. Topsoil moisture supplies were 0 percent very short, 15 percent short, 66 percent adequate, and 19 percent surplus. Subsoil moisture supplies were 1 percent very short, 10 percent short, 70 percent adequate, and 19 percent surplus. Low temperatures ranged from 66.0 degrees Fahrenheit at Ashland to 73.4 degrees Fahrenheit at Biloxi. Highs ranged from 86.7 degrees Fahrenheit at Independence to 94.5 degrees Fahrenheit at Macon. Moderate to heavy precipitation was received throughout the State, with the highest concentration in the central part of the State with an average of 2.92 inches.
