FARM LABOR

MOUNTAIN I REGION (IDAHO, MONTANA, WYOMING)

There were 22,000 workers hired directly by farms in the Mountain I Region (Idaho, Montana, and Wyoming) during the reference week of April 6-12, 2025, according to the Agricultural Labor Survey conducted by the Mountain Regional Field Office of the National Agricultural Statistics Service, USDA. Farm operators paid their hired workers an average wage rate of \$18.67 per hour, compared with \$17.59 in April 2024. The number of hours worked averaged 43.5 for hired workers during the reference week, compared with 44.7 hours in April 2024. Field workers averaged \$18.09 per hour, livestock workers averaged \$17.13 per hour, and field and livestock workers combined earned an average of \$17.60 per hour.

During the reference week of January 12-18, 2025, there were 14,000 workers hired directly by farms in the Mountain I Region. Farm operators paid their hired workers an average wage rate of \$19.61 per hour, compared with \$18.23 in January 2024. The number of hours worked averaged 42.0 for hired workers during the reference week, compared with 42.7 hours in January 2024. Field workers averaged \$19.32 per hour, livestock workers averaged \$17.73 per hour, and field and livestock workers combined earned an average of \$18.13 per hour.

MOUNTAIN II REGION (COLORADO, NEVADA, UTAH)

There were 19,000 workers hired directly by farms in the Mountain II Region (Colorado, Nevada, and Utah) during the reference week of April 6-12, 2025, according to the Agricultural Labor Survey conducted by the Mountain Regional Field Office of the National Agricultural Statistics Service, USDA. Farm operators paid their hired workers an average wage rate of \$18.91 per hour, compared with \$18.91 in April 2024. The number of hours worked averaged 41.8 for hired workers during the reference week, compared with 43.5 hours in April 2024. Field workers averaged \$18.78 per hour, livestock workers averaged \$16.90 per hour, and field and livestock workers combined earned an average of \$17.86 per hour.

During the reference week of January 12-18, 2025, there were 14,000 workers hired directly by farms in the Mountain II Region. Farm operators paid their hired workers an average wage rate of \$19.11 per hour, compared with \$18.85 in January 2024. The number of hours worked averaged 42.5 for hired workers during the reference week, compared with 44.6 hours in January 2024. Field workers averaged \$18.53 per hour, livestock workers averaged \$17.56 per hour, and field and livestock workers combined earned an average of \$17.90 per hour.

MOUNTAIN III REGION (ARIZONA, NEW MEXICO)

There were 14,000 workers hired directly by farms in the Mountain III Region (Arizona and New Mexico) during the reference week of April 6-12, 2025, according to the Agricultural Labor Survey conducted by the Mountain Regional Field Office of the National Agricultural Statistics Service, USDA. Farm operators paid their hired workers an average wage rate of \$18.51 per hour, compared with \$18.06 in April 2024. The number of hours worked averaged 47.5 for hired workers during the reference week, compared with 45.1 hours in April 2024. Field workers averaged \$17.20 per hour, livestock workers averaged \$17.84 per hour, and field and livestock workers combined earned an average of \$17.45 per hour.

During the reference week of January 12-18, 2025, there were 13,000 workers hired directly by farms in the Mountain III Region. Farm operators paid their hired workers an average wage rate of \$18.06 per hour, compared with \$18.09 in January 2024. The number of hours worked averaged 48.1 for hired workers during the reference week, compared with 44.9 hours in January 2024. Field workers averaged \$16.59 per hour, livestock workers averaged \$17.54 per hour, and field and livestock workers combined earned an average of \$16.96 per hour.

UNITED STATES

There were 637,000 workers hired directly by farm operators on the Nation's farms and ranches during the week of April 6-12, 2025, up 3 percent from the April 2024 reference week. Workers hired directly by farm operators numbered 512,000 during the week of January 12-18, 2025, up 3 percent from the January 2024 reference week.

Farm operators paid their hired workers an average gross wage of \$19.52 per hour during the April 2025 reference week, up 3 percent from the April 2024 reference week. Field workers received an average of \$18.58 per hour, up 2 percent. Livestock workers earned \$18.15 per hour, up 4 percent. The field and livestock worker combined gross wage rate, at \$18.43 per hour, was up 3 percent from the 2024 reference week. Hired laborers worked an average of 40.8 hours during the April 2025 reference week, up slightly from the hours worked during the April 2024 reference week.

Farm operators paid their hired workers an average gross wage of \$19.80 per hour during the January 2025 reference week, up 2 percent from the January 2024 reference week. Field workers received an average of \$18.70 per hour, up 1 percent, while livestock workers earned \$18.15 per hour, up 4 percent from a year earlier. The field and livestock worker combined gross wage rate, at \$18.46 per hour, was up 2 percent from the January 2024 reference week. Hired laborers worked an average of 40.0 hours during the January 2025 reference week, up 3 percent from the hours worked during the January 2024 reference week.
