## NEBRASKA CROP PROGRESS AND CONDITION

**LINCOLN, Neb. November 30, 2020** - For the week ending November 29, 2020 there were 5.8 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 24% very short, 41% short, 34% adequate, and 1% surplus. Subsoil moisture supplies rated 31% very short, 40% short, 28% adequate, and 1% surplus.

**Field Crops Report:** Winter wheat condition rated 6% very poor, 20% poor, 39% fair, 33% good, and 2% excellent.

**Pasture and Range Report:** Pasture and range conditions rated 22% very poor, 23% poor, 28% fair, 26% good, and 1% excellent.

This is the last weekly Crop Progress and Condition report for the 2020 growing season. We would like to extend our appreciation to the dedicated county FSA and extension staff who supplied the necessary information for these reports. For December through March, we will issue monthly reports. The first monthly report (for December) will be issued January 4, 2021. Weekly reports will begin April 5<sup>th</sup> for the 2021 season.
