NEBRASKA CROP PROGRESS AND CONDITION

LINCOLN, Neb. May 3, 2021 - For the week ending May 2, 2021, there were 6.1 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 7% very short, 23% short, 68% adequate, and 2% surplus. Subsoil moisture supplies rated 11% very short, 26% short, 62% adequate, and 1% surplus.

Field Crops Report: Corn planted was 42%, behind 55% last year, but ahead of 36% for the five-year average. Emerged was 2%, behind 8% last year, and near 5% average.

Soybeans planted was 20%, behind 29% last year, but ahead of 12% average.

Winter wheat condition rated 6% very poor, 12% poor, 40% fair, 39% good, and 3% excellent.

Sorghum planted was 1%, behind 6% last year, and near 2% average.

Oats planted was 92%, ahead of 86% last year and 80% average. Emerged was 73%, well ahead of 53% last year and 50% average.

Pasture and Range Report: Pasture and range conditions rated 6% very poor, 16% poor, 37% fair, 37% good, and 4% excellent.
