According to the National Agricultural Statistics Service in New Jersey, there were 5.0 days suitable for fieldwork for the week ending Sunday; April 5th, 2020. Topsoil moisture supplies were 5 percent short, 68 percent adequate, and 27 percent surplus. Subsoil moisture supplies were 2 percent short, 77 percent adequate, and 21 percent surplus. Pasture conditions ranged from 65 percent fair to 35 percent good.
