According to the National Agricultural Statistics Service in New Jersey, there were 5.5 days suitable for fieldwork for the week ending Sunday, April 4, 2021. Topsoil moisture supplies were 17 percent short and 83 percent adequate. Subsoil moisture supplies were 17 percent short, 81 percent adequate and 2 percent surplus. Pasture conditions were 24 percent fair and 76 percent good.
