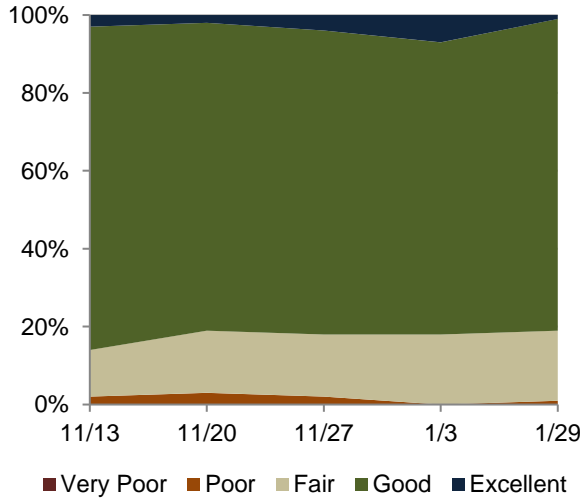

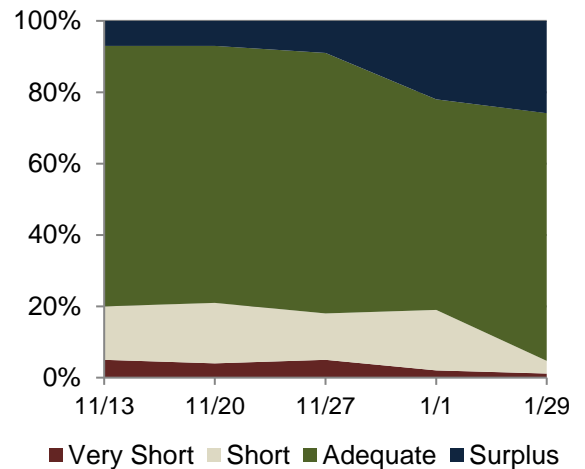

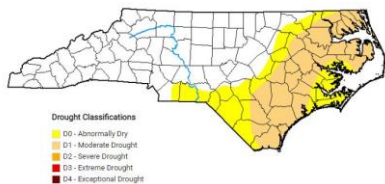
WINTER WHEAT CONDITION



TOPSOIL MOISTURE PERCENT

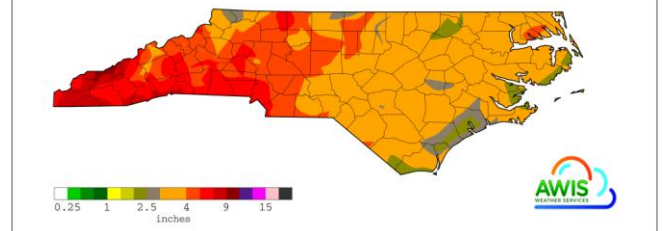


Map depicts current drought conditions as of January 24, 2023.
