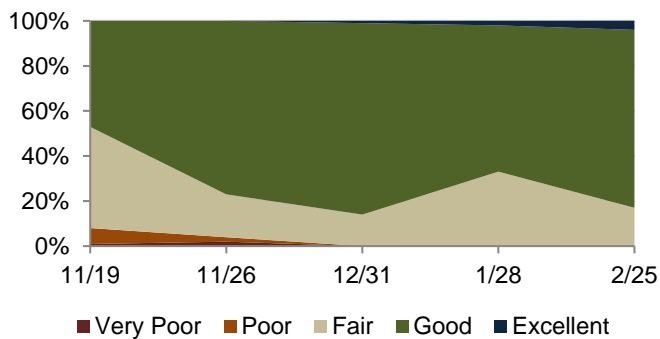

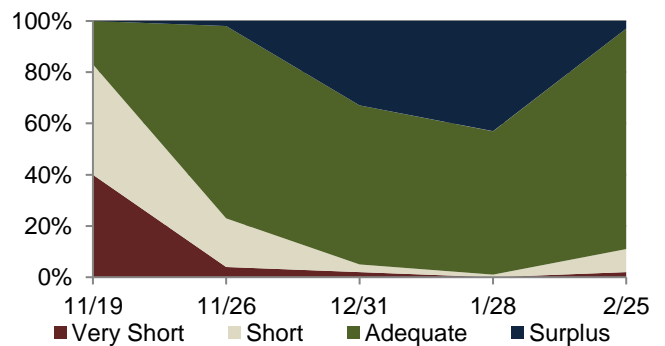

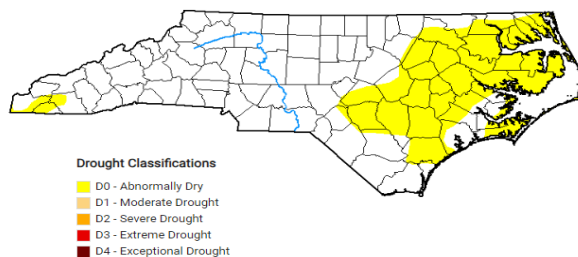
### OATS CONDITION



### TOPSOIL MOISTURE PERCENT

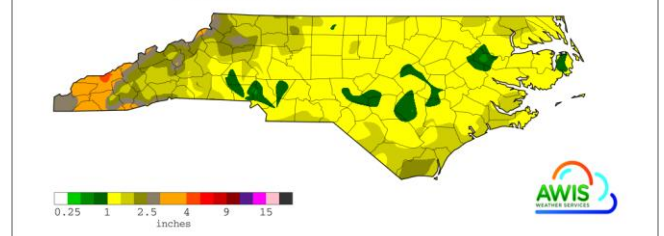


Map depicts current drought conditions as of February 20, 2024.
