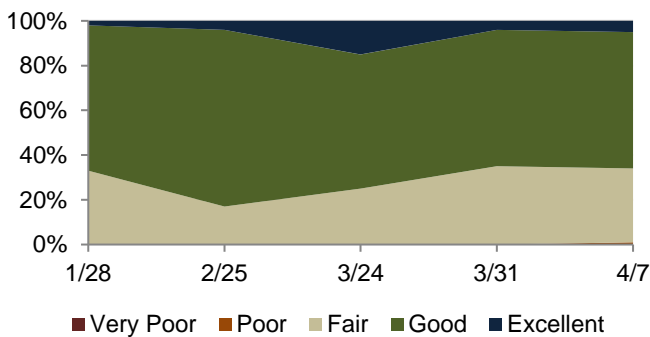

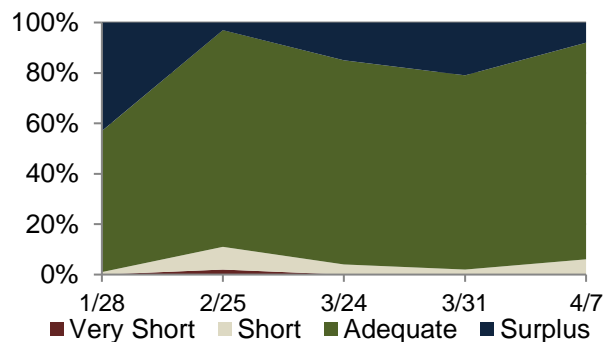

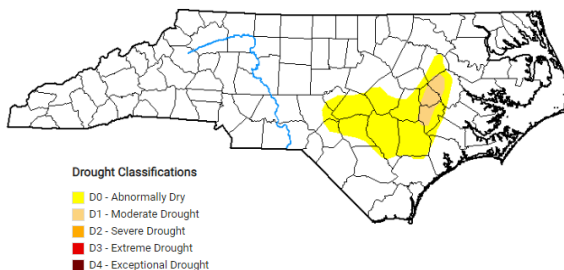
OATS CONDITION



TOPSOIL MOISTURE PERCENT

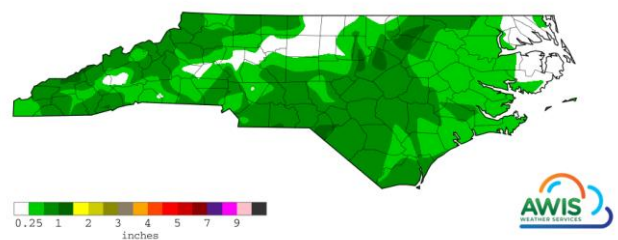


Map depicts current drought conditions as of April 2, 2024.
