NORTH DAKOTA CROP PROGRESS AND CONDITION

FARGO, N.D. May 5, 2025 - For the week ending May 4, 2025, there were 4.6 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 11% very short, 30% short, 57% adequate, and 2% surplus. Subsoil moisture supplies rated 14% very short, 33% short, 51% adequate, and 2% surplus.

Field Crops Report: Soybeans planted was 10%, ahead of 3% last year and 2% for the five-year average.

Spring wheat planted was 35%, ahead of 30% last year and 22% average. Emerged was 8%, near 4% last year, and ahead of 3% average.

Durum wheat planted was 44%, well ahead of 19% last year and 13% average. Emerged was 6%, ahead of 1% last year.

Winter wheat condition rated 12% very poor, 14% poor, 42% fair, 31% good, and 1% excellent. Winter wheat jointed was 5%, behind 11% last year and 16% average.

Corn planted was 17%, ahead of 10% last year and 7% average. Emerged was 1%.

Canola planted was 12%, near 9% last year, and ahead of 6% average.

Sugarbeets planted was 74%, equal to last year, and well ahead of 35% average.

Oats planted was 34%, ahead of 23% last year and 15% average. Emerged was 8%, ahead of 3% last year and 2% average.

Barley planted was 24%, near 22% last year, and ahead of 17% average. Emerged was 5%, near 3% last year and 2% average.

Dry edible peas planted was 31%, ahead of 25% last year and 15% average. Emerged was 3%, equal to last year.

Flaxseed planted was 7%, near 4% both last year and average.

Potatoes planted was 14%, near 17% last year.

Dry edible beans planted was 2%, near 1% last year.

Pasture and Range Report: Pasture and range conditions rated 10% very poor, 20% poor, 36% fair, 33% good, and 1% excellent.

Stock water supplies rated 9% very short, 30% short, 59% adequate, and 2% surplus.
