Weekly Summary for April 8 - April 14

Issued April 15, 2024

Rainfall totals in Oklahoma averaged 0.73 inches. According to the April 9th US Drought Monitor Report, drought conditions were rated 50 percent abnormally dry to exceptional drought, down 10 points from last year. Additionally, 15 percent of the state was in the moderate drought to exceptional drought categories, down 39 points from the previous year. Statewide, temperatures averaged in the upper 50's to lower 60's. Topsoil and subsoil moisture conditions were rated adequate to short. There were 6.1 days suitable for fieldwork.

Small Grains: Winter wheat jointing reached 75 percent, up 15 points from the previous year and up 7 points from normal. Winter wheat headed reached 15 percent, up 4 points from the previous year and up 7 points from normal. Canola blooming reached 9 percent, down 8 points from the previous year and down 23 points from normal. Rye jointing reached 61 percent, up 7 points from the previous year and up 2 points from normal. Oats jointing reached 35 percent, down 11 points from the previous year but unchanged from normal.

Pasture and Livestock: Pasture and range condition was rated at 77 percent fair to good. Livestock condition was rated at 88 percent good to fair.
