Oklahoma hatcheries set 5.80 million eggs in incubators during the week ending June 16, down 3 percent from the week prior and down 22 percent from the previous year.

The number of chicks placed for meat production during the week of June 16, was 3.02 million, down 29 percent from the previous week and down 25 percent from the previous year.

Texas hatcheries set 19.3 million eggs in incubators during the week ending June 16, down 1 percent from the week prior but up 10 percent from the previous year.

The number of chicks placed for meat production during the week of June 16, was 15.3 million, up 1 percent from the previous week and up 5 percent from the previous year.
