#### **Special Note:**

Cattle program changes were made following the 2022 Census of Agriculture. As a result of these changes, a reduced number of data items are published for Alaska beginning in January 2025. Estimates of all cattle and calves inventory, all cows inventory, and calf crop are still published for all states.

### January 1 Cattle Inventory in the Northwest Region Down 2 Percent from Last Year


January 1, 2025 all cattle inventory in Alaska was estimated at 20,000 head, up 5 percent from 2024. All cattle inventory in Idaho was estimated at 2.49 million head, down 2 percent from 2024. Inventory of all cattle in Oregon was 1.23 million head, down 1 percent from last year. In Washington, all cattle inventory totaled 1.12 million head, down 4 percent from January 1, 2024.

Nationally, January 1 all cattle inventory was estimated at 86.7 million head. This was down 1 percent from January 1, 2024. The 2024 calf crop, at the US level, was estimated at 33.5 million head, down slightly from 2023.


