This report contains the results from the March 2024 Hog and Pig Survey. Data provided by Oklahoma and Texas producers are the foundation of the estimates made for the Southern Plains region. We would like to thank all producers who responded to the survey. Results from the next quarterly survey will be made available June 27, 2024.

### Oklahoma Highlights

The March 1, 2024 Oklahoma hog and pig inventory, at 2.00 million head, was 7 percent lower than March 2023. The number of **breeding hogs** totaled 390 thousand head, down 90 thousand from last year. The March 1 **market hog** inventory was down 3 percent from a year ago at 1.61 million head, 81 percent of the total hog and pig inventory.

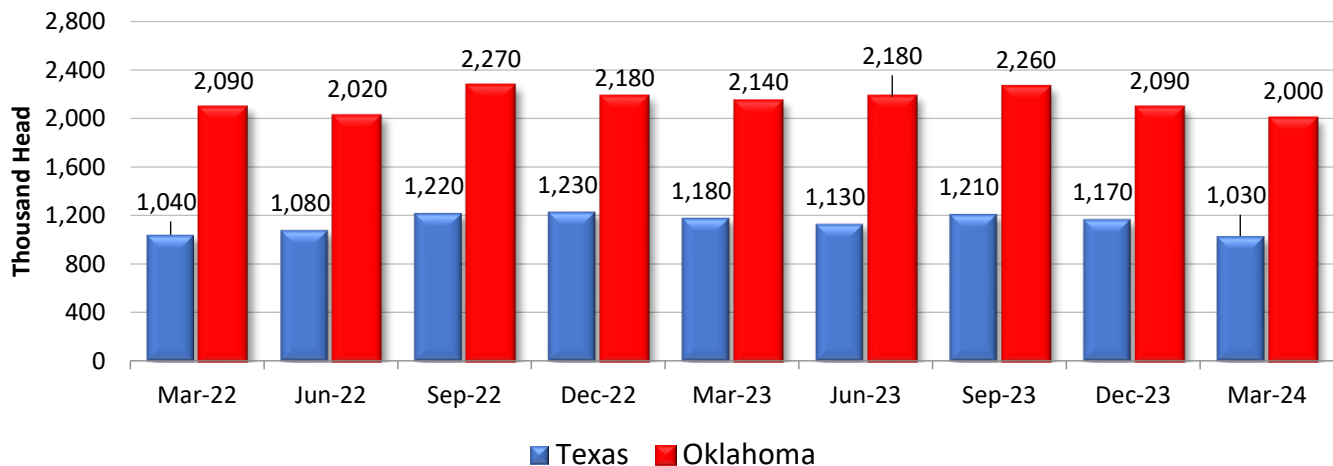
The December 2023-February 2024 Oklahoma **pig crop** totaled 2.02 million head, 3 percent below last year. Pigs per litter averaged 10.9, up 7 percent from the previous year. Sows farrowed during December 2023 through February 2024 totaled 185 thousand head, down 10 percent from last year.

### Texas Highlights

The March 1, 2024 Texas hog and pig inventory, at 1.03 million head, was 13 percent lower than March 2023. The number of **breeding hogs** totaled 125 thousand head, down 45 thousand from last year. The March 1 **market hog** inventory was down 10 percent from a year ago at 905 thousand head, 88 percent of the total hog and pig inventory.

The December 2023-February 2024 Texas **pig crop** totaled 737 thousand head, 11 percent below last year. Pigs per litter averaged 11.7, up 3 percent from the previous year. Sows farrowed during December 2023 through February 2024 totaled 63.0 thousand head, down 14 percent from last year.

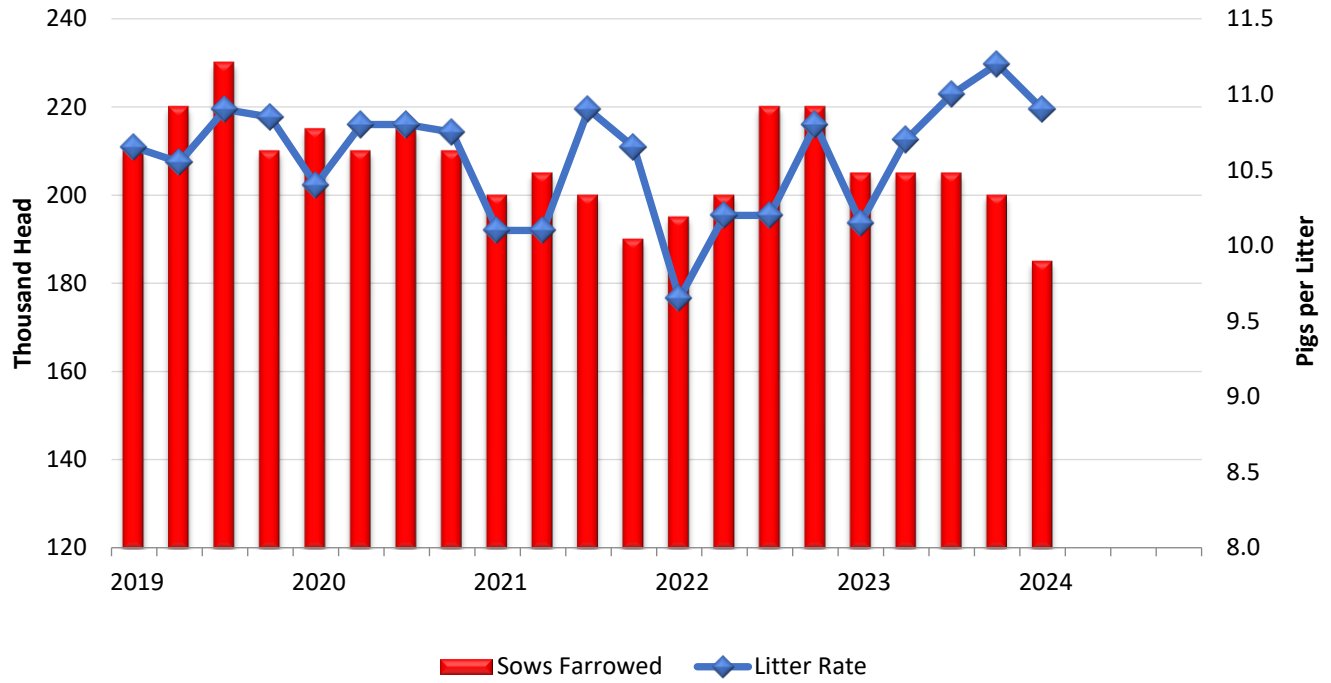

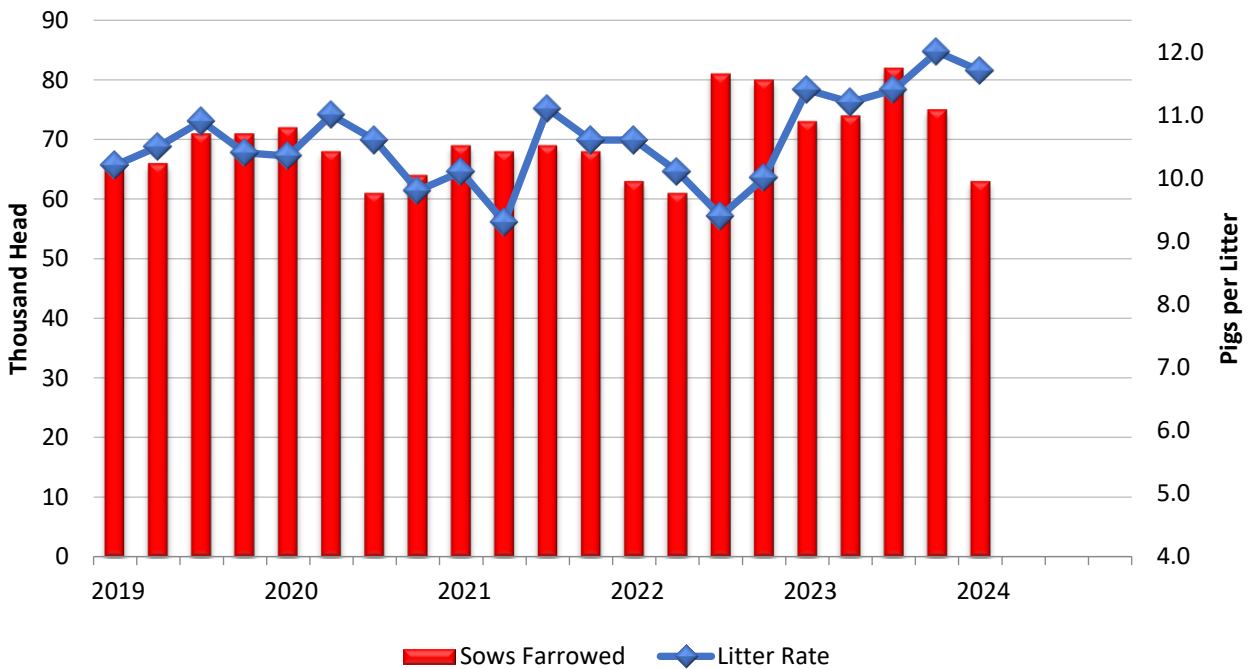

## **U.S. Highlights**

The U.S. inventory of all hogs and pigs on March 1, 2024, is estimated at 74.6 million head, up 1 percent from a year ago but down 2 percent from December 1, 2023. The **breeding hog inventory**, at 6.02 million head, was down 2 percent from last year but up slightly from the previous quarter. **Market hog** inventory, at 68.6 million head, was up 1 percent from last year but down 2 percent from last quarter.

The U.S. **pig crop** for December 2023-February 2024, at 33.1 million, was up 2 percent from 2023. U.S. producers intend to have 2.92 million sows farrow during the March 2024-May 2024 quarter, down 1 percent from the actual farrowings during the same period last year. Intended farrowings for June 2024-August 2024, at 2.99 million sows, are down 2 percent from the same quarter the year prior.
