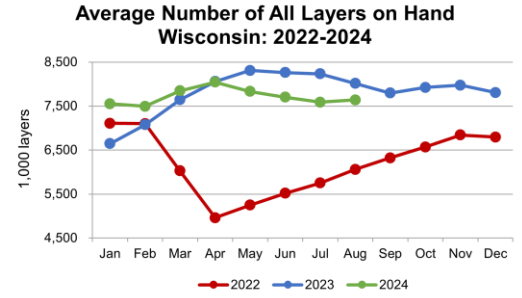

Wisconsin **egg production** during August 2024 was 205 million eggs, down 5 percent from the previous August, according to the latest *Chickens and Eggs* report from the USDA's National Agricultural Statistics Service.

The average number of **all layers on hand** during August 2024 was 7.64 million, down 5 percent from last year. **Eggs per 100 layers** for August was 2,686, up slightly from a year ago.

## United States Chickens & Eggs

United States egg production totaled 9.08 billion during August 2024, down 3 percent from last year. Production included 7.77 billion table eggs, and 1.30 billion hatching eggs, of which 1.21 billion were broiler-type and 95.8 million were egg-type. The average number of layers during August 2024 totaled 370 million, down 3 percent from last year. August egg production per 100 layers was 2,451 eggs, up slightly from August 2023.

Total layers in the United States on September 1, 2024, totaled 372 million, down 3 percent from last year. The 372 million layers consisted of 307 million layers producing table or market type eggs, 61.6 million layers producing broiler-type hatching eggs, and 3.66 million layers producing egg-type hatching eggs. Rate of lay per day on September 1, 2024, averaged 79.3 eggs per 100 layers, up 1 percent from September 1, 2023.

Egg-type chicks hatched during August 2024 totaled 57.4 million, up 9 percent from August 2023. Eggs in incubators totaled 52.0 million on September 1, 2024, up 4 percent from a year ago.

Domestic placements of egg-type pullet chicks for future hatchery supply flocks by leading breeders totaled 263 thousand during August 2024, up 3 percent from August 2023.

Broiler-type chicks hatched during August 2024 totaled 875 million, up 3 percent from August 2023. Eggs in incubators totaled 742 million on September 1, 2024, up 4 percent from a year ago.
